











TRENDING INCREASES FY2017-FY2022

Outgoing Subawards





Unique & New Sponsors FY2019-FY2022

Each year, UI faculty, staff, and students interact with over 1,300 sponsors in the search for external funding, which includes hundreds of entities that are entirely new funding sponsors. For about 40% of proposals, DSP works with sponsors to whom PIs submit 1-6 proposals annually. At the same time, the number of online portals for proposal submission and award management for government and private sponsors has increased extensively. In FY2018 DSP worked with approximately 40 unique sponsor systems; in FY2022 that increased to more than 100 unique systems. DSP maintains institutional accounts within these systems and frequently serves as a help desk by provisioning access for campus and answering questions.

DSP STAFF: COMPLIANCE & CONNECTIONS
