


## **DUA INCREASES FY2016-FY2023** Data Use Agreements (DUA) Negotiations

Data Use Agreements (DUAs) are contracts that govern the exchange and use of data. In recent years, the Division of Sponsored Programs has seen an overall increase in data-sharing and use agreements. This can be attributed to several factors, including engagement in collaborative research with other organizations and an enhanced focus on data privacy, protection, and accountability for the appropriate use of research data.




## **UPWARD TRENDS FY2023**

Monetary Contracts & Amendments Negotiated






# SPONSORS BY NUMBER OF PROPOSALS FY2023
